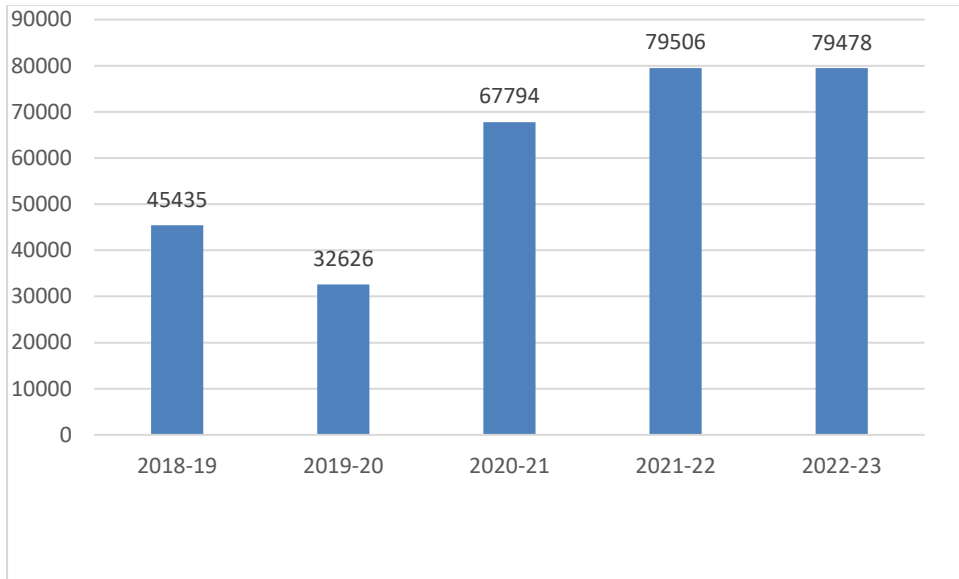

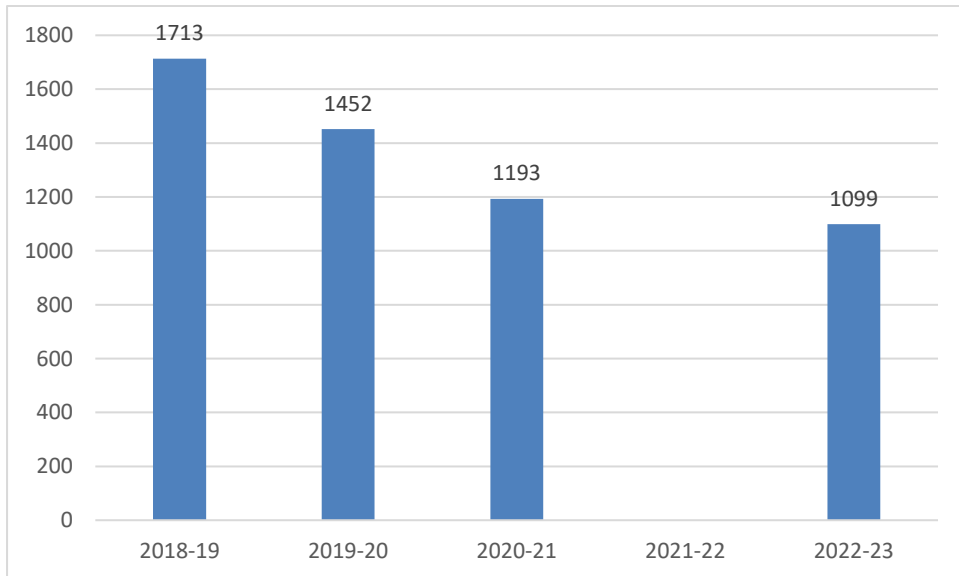

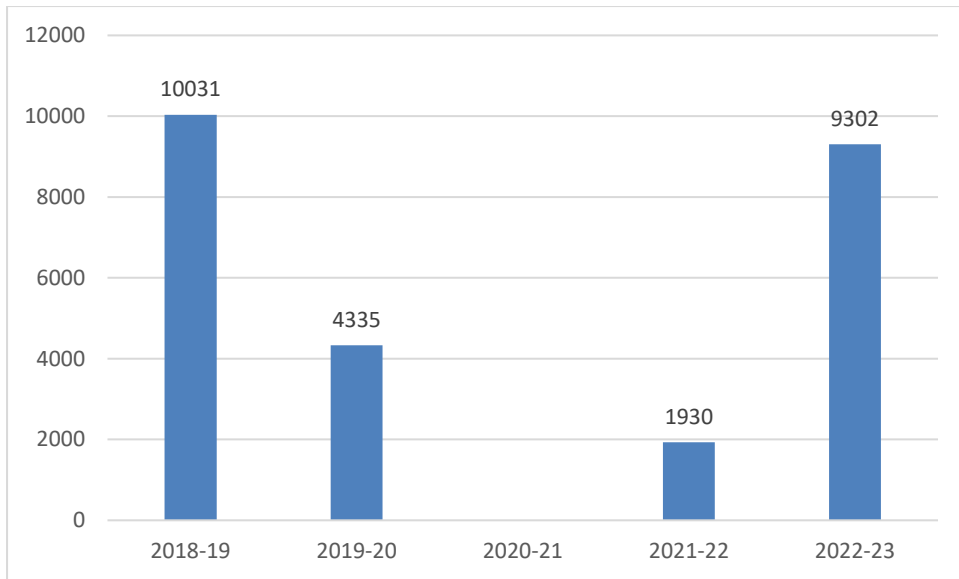
**College OPD data from August 2018 to July 2023.**



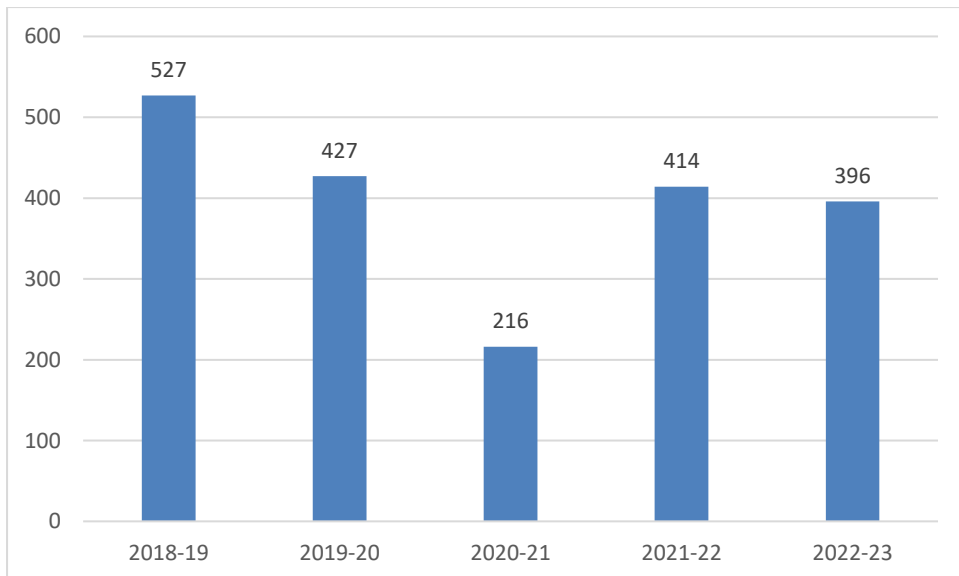
**Rajiv Gandhi Hospital data from August 2018 to July 2023.**



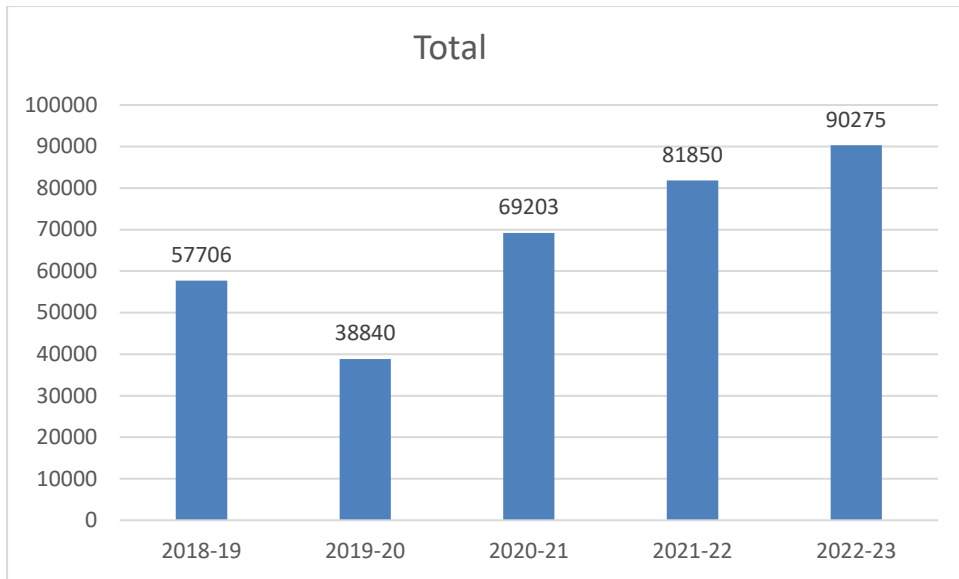
**Camp data from August 2018 to July 2023.**



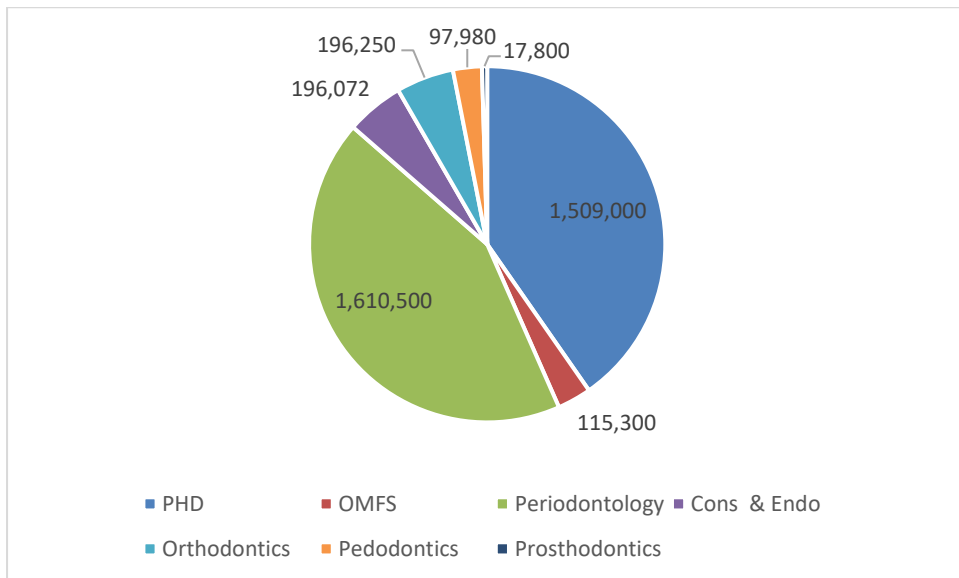
**PHC Charholi data from August 2018 to July 2023.**




