#### **Background:**

This Memorandum of Understanding (MOU) is entered into between **D Y Patil Dental School, Pune** (hereinafter referred to as "Dental School") and **Ayucare Diagnostic Center, Pune** (hereinafter referred to as "CBCT Centre") to establish a long-term collaboration for providing training opportunities to the students of D Y Patil Dental School at the CBCT Centre over a period of **five years** effective from 15/01/2021 to 14/01/2025.

#### **Purpose:**

The purpose of this MOU is to establish a framework for cooperation and collaboration between the Dental School and the CBCT Centre to enhance the educational experience of the students by providing them with training in Cone Beam Computed Tomography (CBCT) imaging techniques and technologies.

### **Terms of Collaboration:**

#### **1. Training Programs:**

- a. The CBCT Centre agrees to provide training programs on CBCT imaging techniques and technologies to the students of the Dental School.
- b. The training programs may include lectures, hands-on sessions, and practical training on the operation and interpretation of CBCT scans.
- c. The schedule and curriculum of the training programs will be mutually agreed upon by both parties.

#### **2. Facilities and Equipment:**

- a. The CBCT Centre agrees to provide access to its facilities and equipment necessary for conducting the training programs.
- b. The Dental School agrees to ensure that its students adhere to the policies and procedures of the CBCT Centre while utilizing its facilities and equipment.

#### **3. Resource Persons:**

- a. The CBCT Centre shall appoint qualified instructors and resource persons to conduct the training programs.
- b. The Dental School may nominate faculty members to participate in the training programs as observers or co-instructors, subject to mutual agreement.

#### **4. Duration and Frequency:**

- a. The duration and frequency of the training programs shall be determined based on the mutual convenience of both parties.

b. Both parties shall strive to conduct regular training sessions to ensure continuous learning opportunities for the students.

### **5. Certification:**

a. Upon successful completion of the training programs, the CBCT Centre may issue certificates of participation or achievement to the students, as deemed appropriate.

b. The Dental School acknowledges that the issuance of certificates by the CBCT Centre is subject to the students meeting the requisite criteria set forth by the CBCT Centre.

### **Confidentiality:**

Both parties agree to maintain the confidentiality of any proprietary information or intellectual property shared during the course of collaboration under this MOU.

### **Termination:**

Either party may terminate this MOU upon providing thirty (30) days' written notice to the other party. Termination shall not affect any rights or obligations accrued prior to the termination date.

### **Amendments:**

Any amendments or modifications to this MOU shall be made in writing and signed by authorized representatives of both parties.

## **Memorandum of Understanding**

This MOU is executed on 11<sup>th</sup> July, 2022 at Dhamangaon by and between **SMBT Institute of Dental Sciences and Research** run by SMBT Sevabhavi Trust, permitted by Dental council of India, having its institution at Nandi hills, Dhamangaon, Tal.- Igatpuri, Dist.Nashik here in after referred to as "SMBT Institute of Dental Sciences and Research" represented by its Dean.

Whereas Between **D Y Patil Dental School, Dr D Y Patil Knowledge City, Charoli Budruk, Via Lohegaon, Pune 412 105, Maharashtra, India** hereinafter referred to as "DYPDS" represented Dean. This MOU is made in reference to activities related to D. Y. Patil Dental School

Whereas both, in accordance with mutual desire to promote learning, research and Development, agree to have a memorandum of understanding (MOU) as follows:

### **(1) Broad objectives:**

This MOU is signed for the purpose of academic collaboration at academic levels that will encompass exchange of students and members of faculty between the two parties. In addition, active efforts will be made to develop joint training and research programs that will be pursued in a collaborative spirit. Some of the collaborative areas may include the following,

1. Joint research & development
2. Facilities sharing platform
3. Jointly organizing seminars, workshops, conferences and other academic activities
4. Conduct of community development program and extension activities for research
5. Collaborative activities for research and innovation.

### **(2) Joint research & development:**

The parties intend to pursue co-operation in research and development supporting the development of technical standards in the fields of medical, dental education and pharmaceutical services.

The parties will meet regularly as needed to discuss possible subjects for future cooperation, to review the state of current cooperative projects and the implementation of the joint cooperation on priority subjects.

The parties intend to enter into project-specific agreements for cooperative scientific and technical activities conducted pursuant to this MOU. Such agreements shall include detailed provisions for the conduct of research and other terms as appropriate.

### **(3) Staff exchange/deputation:**

Both parties agree to explore opportunities for staff exchange between each party. It includes exchange of technical information, reference data, and exchange of visits etc.

Both parties shall encourage teaching in lecture or laboratory environments, sharing of expertise and resources etc., resource persons from either party shall be paid honorarium by the host party for lectures delivered at mutually agreed terms.

Both parties agree that whenever eminent scientists with specialization in the areas of co-operation visits at either institute will be encouraged to visit the other institutes.

Host institution shall not have any financial obligation to either the visiting academic staff or the home party. If the visiting academic staff member falls sick / meets with accident, the parties agree that the host institute will not be held responsible for any costs incurred. All costs associated with travel arrangements, accommodation and associated expenses

shall be the responsibility of the participating academic staff/faculty/research scholar.

Both parties agree that the visiting academic staff shall retain his employee status within the home and will not generally be considered as an employee of the hosting party. However, the visiting staff is expected to abide by the same rules as those for all the staff of the host and applicable rules from the home institution.

**(4) Facilities sharing platform:**

The two parties agree to share their respective facilities in order to promote academic and research interaction on a mutually agreed terms for the purpose of this MOU.

Research scholars of both the parties are welcome to make use of the library resources/ laboratories of each other and to have academic interaction with the faculties.

Research scholars and teaching faculty of both the parties will explore possibility of taking up collaborative research work and also apply for funding from national and international agencies, governments and other funding agencies with the approval of the respective heads of parties.

That for collaborative research projects, publications, and intellectual property rights will be shared in proportion to the input by each party.

**(5) Jointly organizing seminars, workshops, and conferences:**

Both the parties agree to hold/conduct whenever feasible, joint sponsored conferences, seminars, workshops, training programs etc. Participating members shall be treated to be on duty with the parent party for the period of such programs.

The host party shall provide accommodation the participating members from the visiting party wherever feasible and necessary.

**(6) Conduct of community development program / extension activities for the research**

Programs for community development under the aegis of both the parties such as health assistant training etc., shall be conducted. Usage of facilities shall be mutually worked out.

**(7) Mode of operation**

One member from the **D Y Patil Dental School** and one from the **SMBT Institute of Dental Sciences and Research** will be designated as the single point of contact (SPOC) for the coordination role for all programs organized.

**(8) Budgetary provision;**

There may be budgetary provision in both the parties to meet the travel and contingency expenses in connection with the MOU. The budget may be administrated by the respective heads of parties.

**(9) Intellectual property right confidentiality:**

In respect of each project and program of co-operation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining there to.

Neither party shall, at any time disclose to any third party any confidential information of the other party which is acquired in the course of activities under this memorandum, a collaborative project or program, without the prior consent of the other party in writing.

**(10) Co-ordination committee:**

There shall be one co-ordination committee for coordination and monitoring the collaborative programs between the parties consisting of senior person from both the parties.

The co-ordination committee shall review the progress made in the previous academic year, approve the annual plan for cooperation activity from the following year, consider the addition/deletion of areas of co-operation between the parties and consider the continuance of the MOU.

**(11) Amendment and termination:**

This MOU shall be valid for from the date of its signing. During the period of its validity for 3 years, the MOU can be amended at any time by mutual consent of both the parties. This MOU can be terminated by either of the parties by giving advance notice of six months and without jeopardizing the course work or research of any of the students of either party.

**(12) Arbitration/ Jurisdiction:**

Any dispute or differences out of the interpretations of the clauses listed above shall be resolved by mutual consultation and if the mutual consultation fails shall be settled as per the provisions of the Indian arbitration and conciliation act, 1996 and the award of arbitration shall be final and binding on the parties of the MOU. In general courts of Nashik shall have jurisdiction.

The MOU is made out in two original copies one for each of the parties. Both original copies here of are identical and legally equal.

## MEMORANDUM OF UNDERSTANDING

### 1.0 PURPOSE

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote sustainable partnerships and mutual understanding between the Index Institute of Dental Sciences, Index City, NH-59-A Nemawar Road, Indore Madhya Pradesh- 452016 and D.Y. Patil Dental School, Dr. D.Y. Patil Knowledge City, Near Airport, Lohegaon (BK), Charholi, Pune (Maharashtra). Both Index Institute of Dental Sciences and D. Y Patil Dental School may be referred to individually as the "party" or collectively as the "parties".

### 2.0 SCOPE OF ACTIVITIES

Index Institute of Dental Sciences and D.Y Patil Dental School aim to undertake cooperation in areas that may include, but are not restricted to, the following:

- a) Student exchange for research and study
- b) Collaboration of faculty, staff and research scholars
- c) Joint research activities
- d) Continuing education programs
- e) Organization and participation in seminars, symposia, short-term academic programs and academic meetings
- f) The possibility of being a postdoctoral research fellow at either institution; and/or Exchange of research and educational materials, publications and academic information
- g) Technical assistance
- h) Participating in academic juris for post graduate theses and viva

### **3.0 ACTIVITY AGREEMENTS**

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following:

- a) Elaboration of the responsibilities of each institution for the agreed upon activity
- b) Specific schedules for the activity
- c) Budgets and sources of finances for the activity
- d) Detailed management of intellectual property rights and publications
- e) Any other items deemed necessary for the efficient management of the activity

### **4.0 COORDINATORS**

Coordinators shall be named by each institution to serve as liaisons for implementing this MOU. All activities conducted under the auspices of this MOU must have the endorsement of the coordinators. At Index Institute of Dental Sciences, Indore the coordinators will be Dr. Rolly S. Agrawal, Vice Dean & Dr. Rajeev Srivastava, Director- PG Studies and at D.Y. Patil Dental School, Pune the co-ordinators will be Dr. Anagha Shete, Professor and Head, Dept. of Oral Medicine and Radiology & Dr. Varsha Merani, Reader, Dept of Orthodontics.

### **5.0 RENEWAL, TERMINATION AND AMENDMENT**

5.1 This MOU shall remain in force for a period of five years from the date of the last signature. This MOU may be extended by the written consent of the parties.



5.2 This MOU may be terminated by either party giving written notice to the other party at least 180 days in advance of the stated termination date. Termination of this MOU will not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.

5.3 The MOU may be ended only by the written consent of the parties.

## 6.0 CONFIDENTIALITY

1. During the tenure of the MOU both Index Institute of Dental Sciences and D. Y. Patil Dental School, will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this.

**WHEREAS**, it is the objective of the KIMSDU to disseminate, create and preserve knowledge and understanding by teaching, research, extension and service and by effective demonstration and influence of its corporate life on society;

**AND WHEREAS**, the KIMSDU has power to co-operate or collaborate with any other University, institution, authority or organization for research and advisory services and for such purposes to enter into appropriate arrangement with other Universities, institutions, authorities or organizations to conduct certain courses as the situation may demand;

**AND WHEREAS**, the KIMSDU has power to provide for the training and quality improvement of teachers and non-teaching employees;

**AND WHEREAS**, to achieve this goal and objective it is decided to collaborate with the renowned and reputed Universities, institutions and organizations of health sciences for training of faculties and students of affiliated health sciences colleges / recognized institutes by means of teachers (faculty) and students exchange programmes, research programmes and conferences etc.;

**AND WHEREAS**, the "KIMSDU" and "DYP" are discussing a potential for association between themselves for establishing collaboration in the field of training students by adopting and designing their exchange programme;



**AND WHEREAS**, the goal of this collaboration is to foster co-operation and facilitate advancement of knowledge, skill and ideas for betterment of health of the society and common man;

**AND WHEREAS**, it is agreed by mutual discussion between "KIMSDU" and "DYP" to establish a formal collaboration;

**AND WHEREAS**, the parties hereto agreed that detailed terms and conditions guiding the activities identified above shall be designed and formulated separately through mutual discussion;

**AND WHEREAS**, the parties, hereto are desirous to enter into a formal Memorandum of Understanding (MoU) of collaboration, in writing;

NOW THEREFORE, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AND IT IS HEREBY AGREED BY AND AMONG THE PARTIES HERETO, AS UNDER:

**1. OBJECTIVES:-**

**Student exchange:**

- a) **To inculcate goodwill and understanding** by enabling students to study first hand some of the problems and accomplishments of people in institutes other than their own.
- b) **To enable students to advance their education** by studying for some period in an environment entirely different from their own, and undertaking the study of courses and subjects not normally available to them in their own educational setups.
- c) **To give students opportunities to broaden their outlook** by learning to live with and meet people of different cultures, creeds, and working style and by having to cope with day-to-day problems in an environment completely different from the one they have experienced at their setup.
- d) **To have students act as ambassadors** for their own educational setup by imparting as much knowledge as they can of their own institution and region, its attributes and its problems to the people they meet during their period of exchange.
- e) **To provide sufficient time to study and observe another institutes work culture** so that upon returning to their setup students can pass on the knowledge



they have gained by addressing it to administrative officers of organizations and assimilate the positive aspects into their everyday living.

**Teaching faculty exchange:**

- a) **To inculcate goodwill and understanding** by enabling teaching staff to study first-hand some of the problems and accomplishments of the institutes other than their own.
  - b) **To provide opportunity to the teaching staff** to discuss innovations, ideas of patents and areas of possible research collaborations between the two institutes.
  - c) **To have teaching staff act as ambassadors** for their own educational setup by imparting as much knowledge as they can of their own institution and region, its attributes and its problems to the people they meet during their period of exchange.
2. Both the parties will be entered into separate and specific written agreement to govern any specific activity to be initiated to achieve the objectives mentioned above. The terms and conditions of such agreement will be separately determined separately by mutual discussion and consent of both the parties. Such agreement shall come into effect from the date of signing of the -detailed and specific MoU.
3. **STATUS:-**

- a) Neither party will treat any person or group of person less favourably than other or make any discrimination on the grounds of race, religion, caste, ethnic belief, sex, disability, nationality colour or marital status.
- b) Each party will comply with all applicable laws and regulations of INDIA Where there is difference of provision is arises in any law or regulation of the country of any party, such difference shall be settled amicably by mutual discussion and necessary amendment to that effect shall be carried out separately.

**6. TERM, EFFECTIVE DATE AND TERMINATION OF AGREEMENT:-**

This MoU shall become effective from the date of its signing by the representatives of both the parties and shall be remained inforce for the period of FIVE years from the date of its signing. Either party shall terminate this MoU by serving written notice on the registered address of other party or it shall be treated as terminated after the notice period or after completion of any undergoing collaborative programme, as the case may be. The notice period shall not be less than 30 clear days. In such situation both the parties shall act reasonably, that any action or omission of any party shall not affects the good reputation of other party.

- 7. Any doubt, difference or dispute arises with respect to any term mentioned in this MoU shall be settled by mutual discussion between the signatories or authorized representatives of both the parties, however if such doubt, difference or dispute is not resolved amicably the MoU shall be treated as terminated with the consent of both the parties. This MoU shall be governed by and construed in accordance with the laws of INDIA and the Indian courts shall have exclusive jurisdiction.

## **Memorandum of Understanding**

This MOU is executed on 10<sup>th</sup> July, 2019 at Dhamangaon by and between **SMBT Institute of Dental Sciences and Research** run by SMBT Sevabhavi Trust, permitted by Dental council of India, having its institution at Nandi hills, Dhamangaon, Tal. - Igatpuri, Dist. Nashik here in after referred to as "SMBT Institute of Dental Sciences and Research" represented by its Dean.

Whereas Between **D Y Patil Dental School, Dr D Y Patil Knowledge City, Charoli Budruk, Via Lohegaon, Pune 412 105, Maharashtra, India** hereinafter referred to as "DYPDS" represented Dean. This MOU is made in reference to activities related to D. Y. Patil Dental School

Whereas both, in accordance with mutual desire to promote learning, research and Development, agree to have a memorandum of understanding (MOU) as follows:

### **(1) Broad objectives:**

This MOU is signed for the purpose of academic collaboration at academic levels that will encompass exchange of students and members of faculty between the two parties. In addition, active efforts will be made to develop joint training and research programs that will be pursued in a collaborative spirit. Some of the collaborative areas may include the following,

1. Joint research & development
2. Facilities sharing platform
3. Jointly organizing seminars, workshops, conferences and other academic activities
4. Conduct of community development program and extension activities for research
5. Collaborative activities for research and innovation.

### **(2) Joint research & development:**

The parties intend to pursue co-operation in research and development supporting the development of technical standards in the fields of medical, dental education and pharmaceutical services.

The parties will meet regularly as needed to discuss possible subjects for future cooperation, to review the state of current cooperative projects and the implementation of the joint cooperation on priority subjects.

The parties intend to enter into project-specific agreements for cooperative scientific and technical activities conducted pursuant to this MOU. Such agreements shall include detailed provisions for the conduct of research and other terms as appropriate.

### **(3) Staff exchange/deputation:**

Both parties agree to explore opportunities for staff exchange between each party. It includes exchange of technical information, reference data, and exchange of visits etc.

Both parties shall encourage teaching in lecture or laboratory environments, sharing of expertise and resources etc., resource persons from either party shall be paid honorarium by the host party for lectures delivered at mutually agreed terms.

Both parties agree that whenever eminent scientists with specialization in the areas of co-operation visits at either institute will be encouraged to visit the other institutes.

Host institution shall not have any financial obligation to either the visiting academic staff or the home party. If the visiting academic staff member falls sick / meets with accident, the parties agree that the host institute will not be held responsible for any costs incurred. All costs associated with travel arrangements, accommodation and associated expenses

shall be the responsibility of the participating academic staff/faculty/research scholar.

Both parties agree that the visiting academic staff shall retain his employee status within the home and will not generally be considered as an employee of the hosting party. However, the visiting staff is expected to abide by the same rules as those for all the staff of the host and applicable rules from the home institution.

**(4) Facilities sharing platform:**

The two parties agree to share their respective facilities in order to promote academic and research interaction on a mutually agreed terms for the purpose of this MOU.

Research scholars of both the parties are welcome to make use of the library resources/ laboratories of each other and to have academic interaction with the faculties.

Research scholars and teaching faculty of both the parties will explore possibility of taking up collaborative research work and also apply for funding from national and international agencies, governments and other funding agencies with the approval of the respective heads of parties.

That for collaborative research projects, publications, and intellectual property rights will be shared in proportion to the input by each party.

**(5) Jointly organizing seminars, workshops, and conferences:**

Both the parties agree to hold/conduct whenever feasible, joint sponsored conferences, seminars, workshops, training programs etc. Participating members shall be treated to be on duty with the parent party for the period of such programs.

The host party shall provide accommodation the participating members from the visiting party wherever feasible and necessary.

**(6) Conduct of community development program / extension activities for the research**

Programs for community development under the aegis of both the parties such as health assistant training etc., shall be conducted. Usage of facilities shall be mutually worked out.

**(7) Mode of operation**

One member from the **D Y Patil Dental School** and one from the **SMBT Institute of Dental Sciences and Research** will be designated as the single point of contact (SPOC) for the coordination role for all programs organized.

**(8) Budgetary provision;**

There may be budgetary provision in both the parties to meet the travel and contingency expenses in connection with the MOU. The budget may be administrated by the respective heads of parties.

**(9) Intellectual property right confidentiality:**

In respect of each project and program of co-operation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining there to.

Neither party shall, at any time disclose to any third party any confidential information of the other party which is acquired in the course of activities under this memorandum, a collaborative project or program, without the prior consent of the other party in writing.

**(10) Co-ordination committee:**

There shall be one co-ordination committee for coordination and monitoring the collaborative programs between the parties consisting of senior person from both the parties.

The co-ordination committee shall review the progress made in the previous academic year, approve the annual plan for cooperation activity from the following year, consider the addition/deletion of areas of co-operation between the parties and consider the continuance of the MOU.

**(11) Amendment and termination:**

This MOU shall be valid for from the date of its signing. During the period of its validity for 3 years, the MOU can be amended at any time by mutual consent of both the parties. 




